David Palmer (SMI08) - wanted it noted in the minutes that he is still skeptical of Utah elections; GRAMA request was sent for 2020 election results; Lt Governor publicly gave the names of the two women requesting it to the Salt Lake Tribune; no counties responded, except Juab county

Jess Bradfield (County Clerk) - responded & encouraged republicans to look to the future as a party, instead of looking back, look to how we can win; it is the county's responsibility to determine what's legal & what is not when GRAMA requests are made - every county attorney determined it would have been illegal to provide the info requested because it would reveal how everyone voted, which would've denied people their right to a secret ballot; he said there has been an increase in skepticism & complaints, but less volunteers to come help with the balloting process; he welcomes people to come tour the new balloting center to see the election process firsthand
